



# Linear tablet & capsule counting & filling systems



# The CF principle

The counter has three vibratory plates which transport the products from the bulk hopper to the product detection unit and separate them at the same time.

The infrared product detection unit recognizes each single product by its size. Its accuracy and reliability remains unaffected by dust.

The counted products fall straight into the bottle underneath the filling nozzle. The filling nozzle descends onto the bottle neck to prevent product spillage and can even vibrate to prevent product jamming inside.

Two pneumatic gates are used to hold the bottle right underneath the filling nozzle.

The CF-1220 model is a 12-channel high-speed tablet and capsule counter with single-track bottle conveyor.

The counter has a typical output of up to 55 bottles per minute or 5,500 products per minute, depending on the shape and size of both product and bottle.

With GMP stainless-steel machine frame, FDA approved product contact parts and minimum change parts, the CF-1220 is the fastest and most reliable counter for the pharmaceutical and nutraceutical industry.

Cremer counters offer the flexibility of counting any kind of tablet, hard or softgel capsule and filling almost any kind of glass or plastic bottle, with minimal changeover parts.



While the product settles into the bottle, the pneumatic 'memory flaps' collect the precounted products for the next bottle. Pre-counting assures the highest possible output.

In the event of a miscount or incorrectly sized product, the bottle is rejected onto the bottle reject station.

Multiple sensors monitor the bottles for correct positioning, indexing and rejecting to guarantee that only correctly filled bottles leave the conveyor.

The full-colour and touch sensitive operator panel makes the counter easy to operate and fully 21CFR part 11 compliant. A large recipe database enables the operator to easily store and recall machine parameters.

The CF-1220\*2 model is basically the twin version of the CF-1220 model and offers twice the output on a relative small footprint.

The counter has a typical output of up to 100 bottles per minute or 10,000 products per minute, depending on the shape and size and both product and bottle.

At the beginning of the dual-track conveyor the tracks diverge from a single track into two tracks while at the end the two tracks converge into a single track again, to allow full integration into any packaging line.





The CF counters are designed specifically for seamless integration into complete production lines, but can be used as stand alone machines just as well. Both models can be customized to meet specific requirements.

The standard models can also be delivered with extended conveyor or without conveyor, with hand-filling station, double filling nozzle or can be integrated with a high-precision check weigher. To achieve even higher outputs on large counts, both models are also available in a 16-channel execution with speeds respectively up to 7,500 or 15,000 products per minute.
